## TERMS OF TRADING:

New customers/customers without credit accounts: Pro Forma or Credit Card payments apply.

## APPROVED CREDIT ACCOUNTS:

Strictly 30 days net cash payment from date of invoice. In the event of default in operating the facilities, Front Valley Laboratories Ltd reserves the right to charge interest at 4% above Barclays Bank Plc Base Rate for overdue accounts.

**Note:** An administration charge of £25 per month accrues on accounts that remain overdue for more than 60 days from date of invoice. Goods supplied against a credit account remain the property of Front Valley Laboratories until the buyer has made payment in full for the purchase price of those goods and all other goods supplied by the seller.

We do not accept any liability or responsibility for any loss or damage, whether direct or indirect, or consequential to the buyer, purchaser from him, or customer, in respect of non delivery, or delay, or default in delivery of any goods under this contract however caused.

A delivery note will be included with the goods and an invoice will be sent by post after 24 hours. In the event of any failure to arrive in good condition, or with the contents not corresponding to the delivery note, it is required that a **WRITTEN NOTIFICATION** is received within seven days of our invoice. No goods to be returned for any reason without prior written consent from our sales office. No credit notes will be

issued without receipt of goods to Front Valley Laboratories Ltd. The customer is obliged to provide proof of delivery in the event of dispute.

Goods are charged at the price ruling at the time of despatch.

### **NEW ACCOUNTS**

New accounts will only be opened after satisfactory credit references for sums in excess of £500 have been received by Front Valley Laboratories Ltd.

Complaints in respect of alleged late delivery, damage, consequential loss, shall not be grounds for withholding payment of our invoice by the buyer.
